And Yet Another Attack on the 1st Amendment

We Americans take our rights for granted, as if they can never be taken from us. Elsewhere, the world suffers from not having rights at all, even in England. That black sheep (can we still say that?) Prince Harry, admitted to **not understanding** the 1st amendment. And now, the Biden Administration has mounted yet another attack on Free Speech. Our Elite Leaders have barged into a Supreme Court case, Mahanoy Area School District v. B.L., **court file 20-255**, which was heard April 28.

The precis of this case is that B.L. (a minor at the time) had been a cheerleader her freshman year. Sadly, in her Sophomore year, she did not make the varsity squad, and was placed on the JV team.

In a fit of pique, she and some friends made an inappropriate, rude post on Snapchat. The post was captured and sent to the school. She was then suspended from the cheer squad for one year. The post was made off-site from the school, and on a Saturday, not in school hours. A similar case was made previously in Iowa, with the difference that the post had been made on school grounds, during school hours, and it was considered that the post caused a disturbance to learning at the school.

The 3rd Circuit Court ruled for B.L., noting that the offence was made outside the jurisdiction of the school, and therefore, the 1st Amendment protection was upheld.

The school district has appealed to SCOTUS, and the Biden Administration has entered the case to weigh in favor censorship. We await the SCOTUS ruling.

This is yet another example of good intentions growing into bad law. This case actually presents a wonderful opportunity for the parents, teachers and school to create a teaching moment, in which B.L. might have been taught a better way to handle her disappointments. But no, this has become a Federal Case, and will have a major impact on the destruction of our rights.

If the school wins, that will allow all schools to monitor and penalize all students for their speech, whenever and wherever it is made. Maybe even after they graduate. Indeed, it is not beyond the realm of feasibility to imagine a school not liking a post made by a parent. Or a neighbor. Exactly where does the censorship authority end?

And as is always the case, who is to decide what is acceptable speech, and what is not? Will schools be looking to create systems to check everyone's speech?
